ADMISSION TO FIRST YEAR ENGINEERING 2010-11

1.0 Alamuri Ratnamala Institute of Engineering and Technology established in 2008, is run and administered by Koti Vidya Charitable Trust as per the provisions of Bombay Charitable Trust Act 1954.

1.1 Seats are available in the following categories:-

- a) CAP
- b) Institute Level
- c) Against Vacant seats after CAP rounds

Percentage of seats available under CAP, Institute Level will be decided by Pravesh Niyrantran Samiti, Bandra (E), Mumbai. The exact distribution of seats available under the above mentioned categories shall be notified by Director of Technical Education, Mumbai/Pravesh Niyrantran Samiti before submission of application forms.

However it is made expressly clear that if, after issuance of this brochure, any seat(s) and admission(s) allocation difference is there, in such event, a separate intimation will be issued with appropriate details.

GENERAL ELIGIBILITY CONDITIONS:-

1.2 Candidates will be eligible for admission to the first year engineering course as per the eligibility conditions listed below (As per the information brochure of MHT-CET-2010 issued by DTE, Mumbai, Maharashtra)

For Admission to first year full time under-graduate (UG) programmes of Bachelor's Degree in Engineering (B.E.), the candidate should have passed the Higher Secondary Certificate (HSC/Std XII) or equivalent examination from any of the recognized school/board with 50% marks in Physics, Chemistry and Mathematics added together (45% marks for backward class candidates from Maharashtra State only) with English as one of the subjects. The candidate must have either appeared for MHT-CET-2010 and/or should have obtained a non-zero score or positive score in AIEEE 2010.

1.3 Alamuri Ratnamala Institute of Engineering and Technology offers the following five branches in Engineering :-

1.4 All students applying for admission under Institute Level/against CAP vacant seats should fill in the prescribed application form available at Alamuri Ratnamala Institute of Engineering and Technology Office on payment of Rs. 750/- in cash. The schedule of admission process will be published in the leading newspaper/institute website and will be displayed on the college notice board from time to time. The completed application form together with attested copies of supporting documents mentioned below should be submitted in the college office.

a. Application form duly filled

b. Attested copies of

1. SSC or Equivalent mark sheet
2. HSC or Equivalent mark sheet
3. School/Jr. College Leaving Certificate
4. MHT-CET-2010/AIEEE 2010 score card
5. Nationality Certificate
6. Medical Fitness Certificate
7. Caste Certificate (If applicable)
8. Caste Validity Certificate (If applicable)
9. Non Creamy Layer Certificate (If applicable)
10. Any other Certificate as notified by DTE for the Academic Year 2010-11.

1.5 Incomplete application forms may not be considered, therefore, candidate should take care to fill in the form completely.

1.6 Once the application form together with the attested copies of documents are submitted to the college office, candidates will not be permitted to change any entry or submit any fresh copies of documents subsequently.

1.7 Original documents should not be submitted with the application form. Only attested copies are required.

1.8 In the event if any document submitted by the student or the information supplied by him/her is found to be false or incorrect, the admission granted to him/her is liable to be cancelled by the competent authority who would be the Principal.

1.9 FEES:- The fee payable for the course will be intimated separately. Candidates shall also be required to pay the fees as prescribed by the Shikshan Shulka Samiti from time to time. Fees may be paid by Cash or Demand Draft/Pay Order/Bankers Cheque in favour of "ALAMURI RATNAMALA INSTITUTE OF ENGINEERING AND TECHNOLOGY" payable at Shahapur, Thane.

1.10 Cancellation charges :- Applicable as per the directives of Pravesh Niyantaran Samiti/All India Council for Technical Education from time to time.

1.11 The students are hereby informed that Ragging is prohibited in and around the college campus as per the directives of Hon. Supreme court vide SLP No.24295 of 2006.
